This is to inform you that as part of the Liquidation process under the provisions of the Insolvency and Bankruptcy Code, 2016 ("IBC") and Insolvency and Bankruptcy Board of India (Liquidation Process) Regulation, 2016 ("Liquidation Regulation") as amended time to time and as per the advertisement published on 05th September 2019 and subsequent addendums to the main advertisement, the Company on 27th February 2020 has received a bid under E-Auction process for sale of the Company as going concern from M/s.
